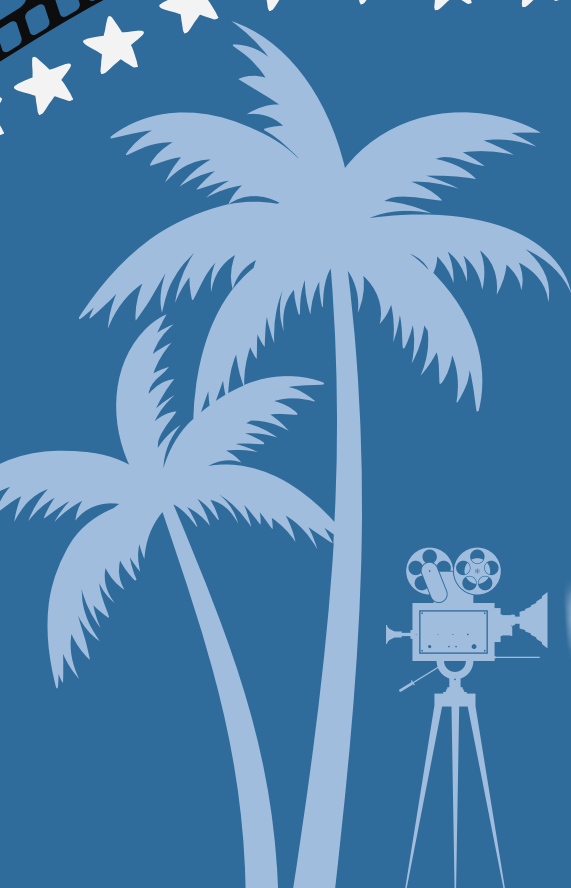

Elevated Exterior Elements Inspection: Compliance with SB 721 and AB 2579

As Building Officials, we have lived the tragedies associated with the 2015 Berkeley Balcony Collapse. We took the time to reflect and assisted the State Legislature with revisions to Health and Safety Code Section 17973. From this point, we saw two pivotal pieces of policy emerge through SB 721 (2018) and AB 2579 (2024). With deadlines for compliance fast approaching, multifamily property owners are looking to their local Building Department to clarify the requirements for inspection of their stairs, balconies, porches, and other exterior elevated elements. Join the conversation as we discuss the process required by recently amended Health and Safety Code via SB 721, and most recently, AB 2579. Our panel of experts will cover due dates for building owners, timeframes for submittal and repair, who can perform the inspections, and the role of your Building Department in ensuring your community is compliant.

Safety Assessment Program: Evaluator and Coordinator Training

The primary focus of this course is to train building inspectors, architects, and civil engineers to perform field evaluations of buildings and other infrastructure for damage along with how to rate the safety significance of that damage. SAP inspectors will be prepared for disaster assessment and the required documentation. This training is also approved by the Federal Department of Homeland Security for homeland security grant funding and provides local governmental representatives with information on how to estimate the local needs for evaluators and other resources that may be needed in response to a local event, how to request the needed resources, how to effectively manage those resources, and how to manage the information gathered by those resources. Up-to-date materials published by the Governor's Office of Emergency Services (Cal OES) are provided.

Residential Wood-Framed Construction Structural Fundamentals

This highly visual and engaging course covers wood framing practices, engineering concepts, and code requirements for residential structures. We'll put together a wood-framed house nail by nail and explain the structural code provisions using common sense terminology along the way. Attendees will gain a solid understanding of wood-framed structures and the skills needed to resolve tough structural situations on plans and in the field. Study topics include: properties of wood as a building material, gravity framing (conventional roofs, roof truss, joists, beams, posts, connections, and foundations), and lateral load path (diaphragms, shear walls, drag struts, and shear transfer connections). The history of residential wood-framed construction will also be explored.

Fire and Smoke Protection Features

This course addresses the critical concepts of the 2021 IBC Chapter 7, Fire and Smoke Protection Features. These concepts provide a basis for the analysis and identification of which components require fire-resistance ratings; where the fire-resistance-rated construction is required in building construction; where smoke-resistant construction is mandated; and the use of fire door assemblies, fire window assemblies, penetration firestop systems, fire dampers and smoke dampers. Participants will be able to apply Chapter 7 provisions to the materials and assemblies used for structural fire resistance, fire-resistance-rated and smoke-resistant construction separation of adjacent spaces.

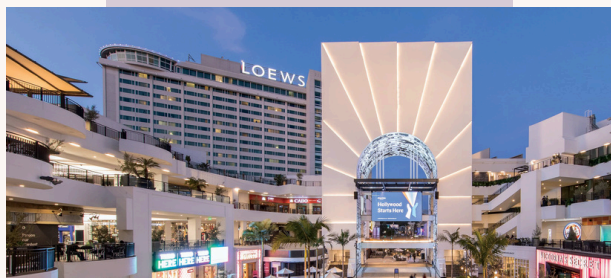

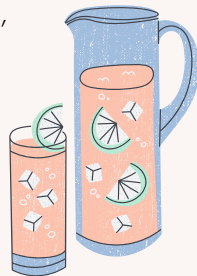
