# Plan Check for Solar Photovoltaic and Energy Storage Systems - 0.6 CEUs

As solar PV systems are constantly changing and improving, this course will update enforcement on the latest codes and design trends that impact this dynamic field. ESS will also be covered as these systems will be incorporated into many PV systems over the next several years.
